



## TSCM - Ensuring Your Private Conversations Stay Private

Think about the last conversation you had on your phone. While you likely weren't discussing state secrets, the discussion was certainly intended to be private to the participants. Now imagine the details of your emails, hands-free phone conversations in your car, or even the last document that came off your wireless printer all being available to an unknown party who was intent on compromising your information for business or personal gain. Uncomfortable at the least and business or politically damaging at the very worst.

Technical surveillance counter measures (TSCM) sweeps are known by many different names: bug sweeping, TSCM inspections, electronic counter-surveillance, etc. But the objective is simple—an electronic and physical check or inspection of a room, building, area, vehicle, yacht, or aircraft. Working with a provider like Red Five who understands both the importance of the equipment used and the quality of the team performing the work is crucial to your security planning.

There are two crucial areas of TSCM, Quarterly and Live TSCM Monitoring, that should be considered.

**Quarterly TSCM Sweeps:** Red Five's technicians perform sweeps at sites ranging from single-room apartments to extensive, large footprint office buildings. The procedures utilized are capable of identifying both active and passive surveillance devices that can record and transmit conversations. Red Five also performs physical searches for hidden devices that operate in a passive collection mode. Quarterly sweeps occur at irregular intervals in order to ensure that adversaries cannot anticipate the inspections.

Red Five provides a comprehensive report after the sweep, which outlines any detected devices that may threaten communications in the inspected area, and also provides recommendations for measures that the client can undertake to mitigate the risk of compromise. These suggested preventative measures address the telephone system, mobile devices, copy and fax machines, as well as company policies and executive communications.

**Live TSCM Monitoring:** Along with the routine needs outlined above, sweeps and electronic monitoring for sensitive corporate and political events and conferences (e.g., board meetings) are also recommended. The practice assures that listening devices are not present in the meeting space prior to the event and provides the ability to detect any new devices introduced into the space during the occasion.
